1. Chulachuli Rural Municipality invites Hard Copy and Electronic bids from Nepalese eligible bidders for Supply of READY TO EAT NUTRITION FOOD under National Competitive Bidding procedures (Firm, Private or Public Limited company registered under The Companies Act, and are who are original manufacturer or producer, Authorized Suppliers of Ready to Eat Nutritional Food in Nepal).
2. 3. Bidders submit their bid Hard Copy and Electronically only & may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid Hard Copy and Electronically, should deposit the cost (as specified below) of bidding document in the Project's Rajaswa(revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of Hard Copy and Electronic submission of the bids. 4. Pre-bid meeting shall be held at Chulachuli Rural Municipality, at **26 January 2021 On 13.00hrs.**
5. Hard Copy and Electronic bids must be submitted to Chulachuli Rural Municipality, through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12.00 on **2 February 2021**. Bids received after this deadline will be rejected.
6. The bidder should have functional and operative manufacturing unit well equipped with appropriate infrastructure and should also have due technical expertise to manufacture or produce the Ready to Eat Nutritional Food as per the product specifications clause of this Tender document.
7. The bids will be opened in the presence of Bidder's representatives who choose to attend **13.00, 3 February 2021** at the office of *Chulachuli Rural Municipality*. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security in cash or Bank guarantee. Scanned copy of the bid security in. pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid.

8. The Tender Inviting Authority reserves the right to accept or reject any or all bid/ offer.
9. The authorized representative of department will have right to inspect manufacturing unit. The bidder shall have to submit samples of ½ kg of each items in the office up to submission date and a test report of the samples submitted from the Govt. approved Department of Food, technology & quality Control with submission of bid document.
10. The bidder must supply all 3 items of Ready to eat nutrition food (**MEETHA DALIYA, NAMKEEN DALIYA, KHICHIDI**) in equal ratio.

11. The supplier will have to print manufacturing date, expiry date, ingredients of the product and other details in the packing. The packets should clearly state that the product is for free distribution (not for sale) and it is not for commercial sale.
  12. The bidder should have in-house quality control facilities, its own quality control laboratory equipped with appropriate laboratory facilities/infrastructure for testing the parameters as per the specifications given in this Tender document.
  13. Blue Print/drawing of the manufacturing unit from where the Micronutrient Fortified Energy Dense Food will be produced and supplied by the bidder and shall have to be submitted along with the bid.
  14. The validity of tender of the successful bidder(s) are bound to supply the items at agreed rates during this period. This period may be further extended for another term of tender or a new tender, and the bidder is bound to supply on the same price.
  15. The quantity mentioned is only the tentative requirement and may increase or decrease as per the decision of Tender Inviting Authority. The rates quoted should not vary with the quantum of the order or the destination.
  16. The selected supplier will have to supply the Ready to Eat Nutritional Food according to the schedule and time table prescribed by the Department. The quantity of each 2 months can be ordered by the department & bidder has to deliver at once.
  17. The successful bidder will have to provide uninterrupted supply of the Ready to Eat Nutritional Food within 60 days of receipt of work order from the Department to the designated destination.
  18. The order Goods as per order shall be handed over to the authorized representative of the purchaser at the purchaser specified single location and the same shall be duly received after ensuring satisfaction to its condition and quantity.
  19. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
